## Invitation to Bid for the Repair/Rehabilitation of FIDA-Fiber Processing and Utilization Laboratory

- The Fiber Industry Development Authority (FIDA), through the General Appropriation Act (GAA) 2013 of the Government of the Philippines (GOP)<sup>1</sup> intends to apply the sum of FOUR MILLION FIVE HUNDRED FIFTY SIX THOUSAND SIX HUNDRED TWENTY NINE PESOS AND 83/100 (Php 4,556,629.83) being the Approved Budget for the Contract (ABC) under the contract for the Repair/Rehabilitation of FIDA-Fiber Processing and Utilization Laboratory with Purchase Request (PR) Number 13-02-242 dated February 21, 2013. Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The Fiber Industry Development Authority now invites bids for Repair/Rehabilitation of FIDA-Fiber Processing and Utilization Laboratory at Bureau of Animal Industry (BAI) Compound, Visayas Avenue, Diliman, Quezon City. The contract includes mobilization/demobilization; provision of temporary facilities, permits and engineering facilities for the engineer; earthworks; concrete works; roofing; masonry works; floor, wall, ceiling, counter-top and counter wall finishes; fabrication of materials and hardwares; waterproofing and concrete topping; painting works; sanitary and plumbing works; electrical works; and protective works. Details on quantities are listed in Section VIII. Bill of Quantities. Completion of the Works is required within 150 calendar days. Bidders should have completed, within three (3) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".
  - Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from **Bids and Awards Committee (BAC)** of the FIDA and inspect the Bidding Documents at the address given below from 8:00 am-5:00 pm.

- **5.** A complete set of Bidding Documents may be purchased by interested Bidders from the address below and upon payment of a nonrefundable fee for the Bidding Documents in the amount of **P4,500.00.**
- 6. The Fiber Industry Development Authority will hold a **Pre-Bid Conference** on **March 1, 2013, 9:30 am** at the FIDA Central Office, 7/F Sunnymede IT Center, Quezon Avenue, Quezon City, which shall be open to all interested parties.

All the interested bidders are invited to join the site inspection on March 1, 2013 at 2:00 pm.

- 7. Bids must be delivered to the address below on or before the **Opening of Bids** on **March 12, 2013 at 9:30 am**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.
  - Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
- 8. The **FIDA** reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
