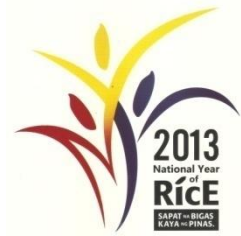

### **INVITATION TO BID FOR CONFERENCE VENUE AND ACCOMMODATION**

(FIDA Management Conference and Planning Workshop, May 6-10, 2013)

The Fiber Industry Development Authority (FIDA), through the General Appropriation Act (GAA) 2013 of the Government of the Philippines intends to apply the sum of SEVEN HUNDRED FIFTY THOUSAND PESOS (**Php 750,000.00**) being the Approved Budget for the Contract (ABC) under the contract name FIDA Management Conference and Planning Workshop 2013 with Purchase Request No. 313. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The FIDA now invites bids for the conference venue, food and accommodation during the FIDA Management Conference and Planning Workshop 2013 on May 6-10, 2013 in **Cavite**. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criterion as specified in the Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the “Government Procurement Reform Act”.

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183 and subject to Commonwealth Act 138.

Interested bidders may obtain further information from the **Bids and Awards Committee (BAC)** of the FIDA and inspect the Bidding Documents at the address given below from 8:00 am-5:00 pm.

A complete set of Bidding Documents may be purchased by interested Bidders starting **March 18, 2013** from the address below and upon payment of a non-refundable fee for the Bidding Documents in the amount of **P1,000.00**.

The FIDA will hold a Pre-Bid Conference on **March 25, 2013, 9:30 am** at the FIDA Central Office, 7/F Sunnymede IT Center, Quezon Avenue, Quezon City, which shall be open to all interested parties.

Bids must be delivered to the address below on or before **April 15, 2013 at 9:30 am**. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on **April 15, 2013, 9:30 am** at the FIDA Central Office, 7/F Sunnymede IT Center, Quezon Avenue, Quezon City. Bids will be opened in the presence of the Bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

The FIDA-BAC reserves the right to accept or reject any bid, to annul the bidding process, and to reject all bids at any time prior to contract award, without thereby incurring any liability to the affected bidder or bidders.
