KNOW ALL MEN BY THESE PRESENTS:

The **PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY**, a national government agency with principal office at 7th Flr. Sunnymede IT Center, 1614 Quezon Avenue, Quezon City, represented by its, OIC, Executive Director, **EDUARDO B. HOLOYOHOY** (hereinafter called the "PROCURING ENTITY");

-and-

HY – INTL UNLIMITED TRADING COMPANY, a partnership duly registered organized and existing under Philippine law, with principal business address at 335 Sen. Gil Puyat Avenue, Pasay City, represented herein by its Authorized Representative **MICHAEL THOMAS GO** (hereinafter called the "SUPPLIER");

WHEREAS, the Entity through Competitive Bidding invited Bids for certain goods and ancillary services, specially, "**PROCUREMENT OF MODULAR PARTITION AND OFFICE FURNITURE FOR THE FIBER UTILIZATION AND TECHNOLOGY DIVISION (FUTD)**", where only one (1) bidder submitted its bid proposal and after deliberation of the Bids and Awards Committee (BAC) -I has accepted the Bid of the Supplier for the lot being the Single Calculated and Responsive Bidder (SCRB)., with the total contract price of **FIVE HUNDRED NINETEEN THOUSAND THREE HUNDRED TWENTY PESOS (Php 519,320.00)** (hereinafter called "the Contract Price");

 - (e) the Special Conditions of Contract; and
 - (f) the Entity's Notification of Award.
3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
