

CONTRACT OF SERVICES

KNOW ALL MEN BY THESE PRESENTS

This agreement made and entered into by and between:

The Fiber Industry Development Authority with postal address at 7th Floor, Sunnymede IT Center 1614 Quezon Avenue, Quezon City, represented herein by its **Administrator, CECILIA GLORIA J. SORIANO, CESO III** herein referred to as **"FIDA"**.

And

Professor **AVELINO D. RAYMUNDO, Ph.D** at the University of the Philippines at Los Baños, married and resident of No. 2 Dairyville, College, Laguna hereinafter referred to as the **"Senior Technical Consultant."**

WITNESSETH

WHEREAS, FIDA is mandated to accelerate the development of the fiber industry in research, extension, utilization, trade regulation, marketing and all its aspects;

WHEREAS, FIDA is implementing the Abaca Disease Management Projects in Region V, VII, VIII and XI covering an estimated of 5,200 hectares of abaca infected with viral disease;

WHEREAS, FIDA desires to engage the professional and technical services of the Consultant;

WHEREAS, the Consultant has signified his willingness and ability to undertake the job;

NOT, THEREFORE, for and in consideration of the foregoing and the mutual covenants of the parties hereinafter specified, the parties have agreed as follows:

1. **SERVICE** – The Senior Technical Consultant shall provide FIDA with the following services:
 - a.. To review and provide technical advices and recommendations on the proposed strategies and schemes in the implementation of the Abaca Management Projects in Leyte;
 - b. To serve as Senior Technical Consultant to the Abaca Disease Management Program in providing directions and guidance in the Program implementation;
 - c. To undertake periodic review and field inspection of the progress of project implementation and evaluate the method being adopted in eradicating the diseased plants;
 - d. To recommend solution to field problems and improvement in order to achieve project objectives efficiently and effectively; and
 - e. To submit quarterly report on his findings, assessments and recommendation for the project, the contract.

2. **PERIOD** – Unless terminated by either party, the contract shall commence on March 15, 2013 to June 30, 2013 with the following schedule of activities:




