

CONTRACT OF SERVICES

This Contract made and entered by and between:

The Fiber Industry Development Authority with postal address at 7th Floor, Sunnymede IT Center 1614 Quezon Avenue, Quezon City, represented herein by its Administrator, **CECILIA GLORIA J. SORIANO, CESO III** herein referred to as "**FIRST PARTY**".

And

Professor **AUGUSTO C. SUMALDE, Ph.D** at the University of the Philippines at Los Baños, married and resident of No. 16 Matapat Street, Jubileeville, Masaya, Bay, Laguna hereinafter referred to as the "**SECOND PARTY**."

WITNESSETH

1. That the FIRST PARTY is in need of the services of the SECOND PARTY who shall perform work not performed by the regular personnel of the FIRST PARTY;
2. That the SECOND PARTY has signified his/her intention, to which the FIRST PARTY has accepted, to provide the service needed by the latter;
3. That the SECOND PARTY hereby possesses the education, experience and skills required to perform the job as prescribed herein;
4. That the SECOND PARTY hereby attest that he/she is not related within the third degree of consanguinity or affinity to the: 1) hiring authority and/or 2) representative of the FIRST PARTY; that he/she has not been previously dismissed from government service by reason of an administrative offense; that he/she has not already reached the compulsory retirement age of sixty-five (65);
5. That in view hereof, the SECOND PARTY is hereby contracted as TECHNICAL CONSULTANT for the project entitled: "Abaca Disease Management Project" being implemented in Regions V, VI, VII, VIII and XI for the period **March 01 2013 to June 30, 2013**, in consideration of a monthly compensation of THIRTY THOUSAND PESOS (30,000.00) only to be paid on a monthly basis;
6. That as a TECHNICAL CONSULTANT, the SECOND PARTY is expected to perform the following functions:
 - To assist and renew technical advices and recommendations on the proposed strategies and schemes in the implementation of the Abaca Disease Management Project;
 - To provide directions and guidance in the implementation of the project;
 - To assist in undertaking periodic review and field and field inspection of the progress of project implementation and evaluate the method being adopted in eradicating the disease plants;
 - To assist and recommend solutions to field problems and improvement in order to achieve project objectives efficiently and effectively; and
 - To submit inception, progress and final reports of his findings, assessments and recommendations for the project.
7. That the SECOND PARTY shall perform work at a place, time and schedule to be agreed upon by both parties;


