

NOW, THEREFORE, We, the members of the Bids and Awards Committee (BAC), hereby **RESOLVE**, as it is **RESOLVED**, to declare Sunverde Hotels and Resorts, Inc. as a Single Rated and Responsive Bid and to recommend to the Head of the Procuring Entity the award of contract to the same bidder.

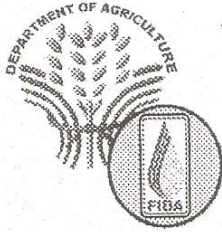

INVITATION TO BID FOR CONFERENCE VENUE AND ACCOMMODATION (FIDA Management Conference and Planning Workshop, May 6-10, 2013)

The Fiber Industry Development Authority (FIDA), through the General Appropriation Act (GAA) 2013 of the Government of the Philippines intends to apply the sum of SEVEN HUNDRED FIFTY THOUSAND PESOS (Php 750,000.00) being the Approved Budget for the Contract (ABC) under the contract name FIDA Management Conference and Planning Workshop 2013 with Purchase Request No. 313. Bids received in excess of the ABC shall be automatically rejected at bid opening.

Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project.
