**Declaration of Failure of Bidding**

**WHEREAS**, the Philippine Fiber Industry Development Authority (PhilFIDA) prepared Purchase Request No. 18-04-244 for *Provision of Fuel, Oil and Lubricants of All PhilFIDA Official Vehicles thru the Use of Fleet Cards for a Period of One (1) Year from October 1, 2018 to September 30, 2019 (ABC= PhP4,032,000.00)*;

**WHEREAS**, after the posting of the Invitation to Bid (ITB) at PhilGEPS (Ref. No. 5530805), the PhilFIDA BAC did not receive any bid during the scheduled submission of bids on or before 9:00 AM of 23 August 2018, thus the 1st bidding was declared as “failed”;


**WHEREAS**, the BAC posted an ITB at PhilGEPS (Ref. No. 5585637) for the rebidding but for the 2<sup>nd</sup> time the PhilFIDA BAC did not receive any bid during the scheduled submission before 9: 00 AM of 18 September 2018, hence the rebidding was declared as “failed”;

**WHEREAS**, Section 53 of the same Act provides that where there are two failed competitive biddings the Procuring Entity can do procurement through a Negotiated Procurement whereby the Procuring Entity directly negotiates a contract with a technically, legally and financially capable supplier, contractor or consultant;


**NOW, THEREFORE**, the BAC hereby resolves, as it is hereby resolved, to recommend to the Head of Procuring Entity (HoPE) the approval of the declaration of failure of bidding for the procurement of the Fleet Cards and resort to Negotiated Procurement;


