**WHEREAS**, the BAC posted Invitation to Bid at the PhilGEPS (Ref. No. 6875123) on February 24, 2020 and conducted the Pre-Bidding Conference on March 02, 2020, 1:00p.m. at PhilFIDA Conference Room;

**WHEREAS**, during the Pre-Bidding was held and attended by representatives of several prospective bidders;

**WHEREAS**, during the discussion on the technical specification some prospective bidders raised issues with the End User, has to do in-depth market research.

**WHEREAS**, Section 41.C, "For any justifiable and reasonable ground where the award of the contract will not redound to the benefit of the government as defined in the IRR" of R.A. 9184.

**WHEREAS**, the modification of specification and review of the Market Research by the End Users deemed significant changes, to proceed with the ongoing procurement is not technically feasible, hence, will not redound to the benefit of the Government of the Philippines.

**NOW, THEREFORE**, We, the members of the PhilFIDA BAC, hereby **RESOLVE**, as it is **RESOLVED**, to recommend to the Head of the Procuring Entity the approval of the declaration of Cancellation of Procurement of **Real Time PCR Cyclers** in order to deeper the evaluation of the Market Research.
