## Invitation to Bid for the Construction of Ilocos Cotton Processing Center (Phase II) Center at Brgy. Lumbaan-Bicbica, Pinili, Ilocos Norte

- 1. The Philippine Fiber Industry Development Authority (PhilFIDA) through the Department of Agriculture intends to apply the sum of Four Million Pesos (P4.0M) being the Approved Budget for the Contract (ABC) to payments under the contract for the Construction of Ilocos Cotton Processing Center (Phase II). Bids received in excess of the ABC shall be automatically rejected at bid opening.
- 2. The PhilFIDA now invites bids for the Construction of Ilocos Cotton Processing Center (Phase II); that includes Preliminaries, Site Preparation, Earthworks, Concrete and Masonry Works, Scaffoldings and Form Works, Doors and Windows, Roof and Wall Framing Works, Carpentry and Fabrications, Electrical Works, Painting Works and Perimeter Fence. Completion of the Works is required in One hundred twenty (120) calendar days. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
- 3. Bidding will be conducted through open competitive bidding procedures using non discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."
  - Bidding is restricted to Filipino citizens/sole proprietorships, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
- 4. Interested bidders may obtain further information from the *PhilFIDA* and inspect the Bidding Documents at the address given below during office hours from 9:00 a.m. to 4:00 pm.
- 5. A complete set of Bidding Documents may be acquired by interested bidders on March 3, 2021 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Four Thousand Hundred Pesos (PhP 4,000.00).
  - It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the

Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

- 6. The *PhilFIDA* will hold a Pre-Bid Conference on *March 3, 2021 1:00 am* at *PhilFIDA Conference Room, Batac City*, which shall be open to prospective bidders.
- 7. Bids must be duly received by the BAC Secretariat at the address below on or before *March 17, 2021 1:00 pm*. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18

Bid opening shall be on *March 17, 2021, 1:30 pm* at *PhilFIDA Conference Room, Batac City*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

- 8. The Bidders shall drop three (3) copies of their duly accomplished eligibility requirement, technical and financial proposals in two (2) separate sealed envelopes in the bid box located at the above-mentioned address.
- 9. The *PhilFIDA* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
