CONTRACT AGREEMENT No. CA-006-2021

THIS AGREEMENT, made this ______ day of *November* 2021 between **PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY (PhilFIDA)** with principal address at 3/F DA-PCAF Building, DA Compound, Elliptical Road, Diliman, Quezon City (hereinafter called the "Entity") and **INDUSTRIAL & TRANSPORT EQUIPMENT, INC. (INTECO)** with office address at 1669 Sgt. Esguerra St., West Triangle, Quezon City (hereinafter called the "Contractor").

WHEREAS, the Entity is desirous that the Contractor executes the **Supply, Delivery** and **Testing of Branded and Brand New Cab and Chassis Truck (Lot 1)** (hereinafter called "the Works") and the Entity has accepted the Bid for **Two Million One Hundred Thirty-Eight Thousand Seven Hundred Fifty Pesos (PhP2,138,750.00)** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as part of this Agreement, *viz.*:
 - a. Philippine Bidding Document (PBD);
 - i. Instructions to Bidders:
 - ii. General and Special Conditions of Contract;
 - iii. Schedule of Requirements;
 - iv. Technical Specifications;
 - v. Supplemental or Bid Bulletins, if any;
 - **b.** Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c. Performance Security;
- d. Notice of Award of Contract and the Bidder's conforme thereto; and
- e. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.



- 3. In consideration for the sum of Two Million One Hundred Thirty-Eight Thousand Seven Hundred Fifty Pesos (PhP2,138,750.00) or such other sums as may be ascertained, INDUSTRIAL & TRANSPORT EQUIPMENT, INC. (INTECO) agrees to satisfactorily complete the Supply, Delivery and Testing of Branded and Brand New Cab and Chassis Truck (Lot 1) in accordance with his/her/its Bid.
- 4. The **(PhilFIDA)** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
