

# SUPPLY CONTRACT AGREEMENT

## KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT is executed and entered into for all purposes and in all respect at \_\_\_\_\_ day of \_\_\_\_\_ 2022 by and between:

**PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY** with principal office address at 3/F DA-PCAF Bldg., Department of Agriculture, Elliptical Road, Diliman, Quezon City, represented by **KENNEDY T. COSTALES**, Executive Director III, hereinafter referred to as "**the Procuring Entity**".

And

**BONGBONG MECHANICAL SHOP** with business address at National Highway, Barangay Poblacion (Santa Fe), Imelda, Zamboanga Sibugay represented by **SIMEON P. LAGURA**, owner/manager, hereinafter referred to as "**the Supplier**".

## WITNESSETH THAT:

WHEREAS the Procuring Entity invited Bids for goods, viz., "**Fabrication, Delivery, Installation and Testing of Series-type Combined Abaca Spindle-Deco Fiber Extraction Machine**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **Two Million Five Hundred Thousand Pesos (PhP2,500,000.00)** (hereinafter called "the Contract Price").

## NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract herein referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulation of Republic Act No. 9184 shall be deemed to form, and be read and construed, as part of this Agreement, viz.:
  - a) Philippine Bidding Documents (PBDs):
    - i. Drawings/Plans;
    - ii. Specifications;
    - iii. Request for Quotations;
    - iv. General Conditions of Contract;
    - v. Supplemental or Bid Bulletins, if any;
  - b) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Handwritten signatures and initials on the right margin, including a large signature at the top and another signature below it, and a circular stamp or signature at the bottom.

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- c) Performance Security;
  - d) Notice of Award of Contract and the Bidder's conform thereto; and
  - e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **Two Million Five Hundred Pesos (PhP2,500,000.00)** or such other sums as may be ascertained. **Bongbong Mechanical Shop** agrees to satisfactorily complete the **Fabrication, Delivery, Installation and Testing of Series-type Combined Abaca Spindle-Deco Fiber Extraction Machine in accordance with his/her/its Bid.**
4. The (PhilFIDA) agrees to pay the above-mentioned sum in accordance with the terms of the bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


