

SUPPLY CONTRACT AGREEMENT

KNOW ALL MEN BY THESE PRESENTS:

THIS AGREEMENT is executed and entered into for all purposes and in all respect at **QUEZON CITY** on **MAY 11 2022** by and between:

PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY with principal office address at 3/F DA-PCAF Bldg., Department of Agriculture, Elliptical Road, Diliman, Quezon City, represented by **KENNEDY T. COSTALES**, Executive Director III, hereinafter referred to as "**the Procuring Entity**".

And


ESTANCIA DE LORENZO with business address at Saint Patrick St., Brgy. Gulod Malaya, San Mateo, Rizal represented by **ABIGAIL F. ERFE**, Account Executive, hereinafter referred to as "**the Supplier**".

WITNESSETH THAT:

WHEREAS the Procuring Entity invited Bids for goods, viz., "**Venue, Food and Accommodation AFMD Coaching and Review of Citizens' Charter**" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **One Hundred Ninety-Eight Thousand Pesos (PhP198,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The Supplier's Price Quotation shall be deemed to form, and be read and construed, as part of this Agreement.
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.




4. Aside from the liquidated damages to be paid by the Supplier in case of delay as stipulated in the Supplier's Price Quotation, the Procuring Entity may rescind this Agreement in case of the unreasonable failure of the Supplier to deliver the goods and services. Such rescission may be done extra judicially by the Procuring Entity.
5. Any court action which may accrue in relation to this Agreement shall be tried exclusively in the Regional Trial Courts of Quezon City only.
6. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed.


