OTUS COPY SYSTEMS, INC. with business address at No. 10F MG Tower 75 Shaw Blvd., 1552 Mandaluyong City represented by CLAIRE B. JOSEPH, Authorized Representative, here nafter referred to as "the Supplier".

WITNESSETH THAT:

WHEREAS the Procuring Entity invited Bids for goods, viz., "Rental/Lease of Black and White Multi-Function Copier" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Hundred Thirty Six Thousand Eight Hundred Pesos (Ph P136,800.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreen ent, words and expressions shall have the same meanings as are respectively as signed to them in the Conditions of Contract referred to.
- 2. The following locuments shall be deemed to form, and be read and construed, as part of this Agreement, viz.,:
 - a) The Supplier's Price Quotation; and
 - b) Job Order No. 002-2022.
- 3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.





- 4. Aside from the liquidated damages to be paid by the Supplier in case of delay as stipulated in the Supplier's Price Quotation, the Procuring Entity may rescind this Agreement in case of the unreasonable failure of the Supplier to deliver the goods and services. Such rescission may be done extra judicially by the Procuring Entity.
- 5. Any court action which may accrue in relation to this Agreement shall be tried exclusively in the Regional Trial Courts of Quezon City only.
- 6. The Procuring entity hereby covenants to pay the Supplier in consideration of the provision of the goods and the remedying of defects therein, the Contract price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed.
