

SUPPLY CONTRACT AGREEMENT

THIS AGREEMENT is executed and entered into for all purposes and in all respect at 13th day of May 2022 by and between:

PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY with principal office address at M/F LDM Building, M.J. Cuenco Avenue corner Legaspi Street, cebu City, Cebu represented by **MR. JOSEPH S. SALAS**, Officer-in-Charge, hereinafter referred to as the "Procuring Entity"

ALTA BOHOL GARDEN RESORT, INC with official address at Brgy. San Isidro, Baclayon, Bohol represented by **CHRISTINE S. MALAIT**, Sales Manager, hereinafter referred to as the "Supplier"

WITNESSETH THAT:

WHEREAS, the Procuring Entity invited Bids for goods and services for Venue, Food and Accommodation in the Conduct of Training-Workshop on the Development of Modules for the Manual on Abaca Production Phase 2 on May 23-27, 2022 and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Five Hundred Fifteen Thousand Two Hundred pesos only (P515,200.00) hereinafter called the "Contract Price"

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:


1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to
2. The Supplier's Price Quotation shall be deemed to form and be read and construed as part of this Agreement
3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Procuring Entity to provide the goods and services and to remedy defects therein in conformity in all respects with the provisions of the Contract
4. Aside from the liquidated damages to be paid by the Supplier in case of delay as stipulated in the Supplier's Price Quotation, the Procuring Entity may rescind this Agreement in case of the unreasonable failure of the Supplier to deliver the goods and services. Such rescission may be done extra judicially by the Procuring Entity
5. Any court action which may accrue in relation to this Agreement shall be tried exclusively in the Regional Trial Courts of Cebu City only
6. The Procuring Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed
7. That the Second Party may be required to submit additional supporting documents in accordance with the existing COA rules and regulation

8. That the Supplier shall provide the list of food served based on the Menu stated at the Purchase Order
9. That the Supplier shall abide with the terms and conditions as stipulated in the Purchase Order
10. Processing for check payment will commence after receipt of duly signed Statement of Account from the Supplier and Inspection and Acceptance Report by PhilFIDA RO VII designated personnel subject to the availability of funds
