Bids and Awards Committee Resolution No. 001-2024

Recommending Award of Contract to CMPT Manpower Services as the Lowest Calculated Responsive Bid (LCRB) for the "Provision of Janitorial Services"

WHEREAS, the approved budget FY2024 Annual Procurement Plan (APP) of the Philippine Fiber Industry Development Authority includes the "Provision of Janitorial Services" through Public Bidding with an Approved Budget of Two Million Twenty-Seven Thousand Seven Hundred Twenty-Three Pesos and Four Centavos (PhP 2,027,723.04);

WHEREAS, the End-user, Administrative, Financial and Management Division submitted Purchase Request (PR) Nos. 24-01-016 and 24-016 for the "Provision of Janitorial Services" dated January 12, 2024 and January 17, 2024 respectively;

WHEREAS, the BAC published on PhilGEPS through public bidding the Public Bidding Documents (Project Identification No. PB-001-2024) with Reference No. 10550635 on February 13, 2024 and ended last March 11, 2024;

WHEREAS, the BAC conducted the pre-bid conference on February 23, 2024 at 1:30PM and the opening of bids on March 11, 2024 at 10:30AM;

WHEREAS, two bidders, Cancu Enterprises and General Services, Inc. and CMPT Manpower Services submitted their bidding proposals within the deadline of submission of bids;

WHEREAS, during the opening of bids, both bidders passed the technical and financial requirements, but CMPT Manpower Services offered the lowest bid of Two Million Fifteen Thousand Seven Hundred Seventy-Nine Pesos and Eighty-One Centavos (PhP2,015,779.81) while CANCU Enterprises and General Services, Inc. offered Two Million Twenty-Two Thousand One Hundred Sixty-Five Pesos and Sixty Centavos (PhP2,022,165.60);

WHEREAS, the Technical Working Group (TWG) conducted evaluation and post qualification of the bid offered by CMPT Manpower Services on March 12, 2024 and March 13, 2024 respectively and found to be compliant with the legal, technical and financial requirements; thereby recommending the award of contract as indicated in the Post Qualification Report dated March 13, 2024;

WHEREFORE, the BAC, RESOLVED, AS IT IS HEREBY RESOLVED to RECOMMEND to the HoPE to award the contract for the "Provision of Janitorial Services" to CMPT Manpower Services with a contract price of Two Million Fifteen Thousand Seven Hundred Seventy-Nine Pesos and Eighty-One Centavos (PhP2,015,779.81);
