THIS AGREEMENT made the \_\_\_\_\_ day of <u>8</u> <u>APR</u> 2025 between **PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY (PhilFIDA)** with principal address at Fiber Processing and Utilization Laboratory, BAI Compound, Visayas Ave., Brgy. Vasra, Quezon City (hereinafter called "the Entity") of the one part and **RAINPHIL INC.** with principal address at 2/Ff Lot 2 Blk.27 Arellano cor. Olivarez Sts., Palanan, Makati City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "Supply, Delivery, Installation and Orientation of Automated PCR Setup Workstation" under the "Supply and Delivery of Laboratory Equipment – 8 Lots" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of One Million Six Hundred Eighty Thousand Pesos (PhP1,680,000.00) (hereinafter called "the Contract Price").

  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;
  - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
  - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract</u> <u>execution, such as the Notice to Proceed, Variation Orders, and Warranty</u> <u>Security, shall likewise form part of the Contract.</u>

WHEREAS, the approved FYs 2024 and 2025 Annual Procurement Plan (APP) of the Philippine Fiber Industry Development Authority (PhilFIDA) includes the "Supply and Delivery of Laboratory Equipment – 8 Lots" through Public Bidding with an Approved Budget for Contract (ABC) of Five Million Two Hundred Seventy-Five Thousand Pesos (PhP5,275,000.00) funded through the Department of Science and Technology - Philippine Council for Agriculture, Aquatic and Natural Resources Research and Development (DOST-PCAARRD) Project 4;

WHEREAS, the end-user, the Research Division submitted the following Purchase Requests:

**WHEREAS**, the previous BAC sent a letter of invitation on November 22, 2024 to PhilFIDA COA Resident Auditor and two (2) other institutions, namely: Philippine Chamber of Commerce and Industry (PCCI) and Philippine Institute of Chemical Engineers (PIChE) as observers.

WHEREAS, the previous BAC conducted the pre-bid conference on November 29, 2024 at 1:30 P.M. through MS Office Teams and was attended online by twelve (12) suppliers namely: 1) Brownstone Asia Tech Inc., 2) MMJ Biosystems Phils Inc., 3) Grimit Laboratory Furnitures and Equipment Corp., 4) Molave Trading Inc., 5) ITS Science Phils. Inc., 6) Mt. Zion Scientific Inc., 7) Labtraders Inc., 8) Pro Maintech Consultancy, Inc., 9) Golden Bat (Far East) Inc., 10) Chemisphere Lab Sciences, 11) Noveaulab Asia Corp., and 12) Rainphil Inc.;

WHEREAS, during the pre-bid conference, Ms. Estrada of MMJ Biosystems requested the BAC that the delivery period for all lots be sixty (60) instead of thirty (45) calendar days while Labtraders Inc. requested that Ultra-Low Particulate Air (ULPA) may also be offered aside from "HEPA filter" for lot nos. 4, 7 and 8;

**WHEREAS**, the previous BAC together with the end-user, Mr. Jayson C. Asunto, unanimously agreed to all suggestions of MMJ Biosystems and Labtraders Inc., thus the attached Supplemental Bid Bulletin (SBD-009-2024) which was uploaded to the PhilGEPS and PhilFIDA websites on December 2, 2024;

WHEREAS, on December 12, 2024, the previous BAC conducted a bid opening and eight (8) suppliers namely: 1) Grimit Laboratory Furnitures and Equipment Corp., 2) Mt. Zion Scientific Inc., 3) Labtraders Inc., 4) Pro Maintech Consultancy, Inc., 5) Golden Bat (Far East) Inc., 6) Chemisphere Lab Sciences, 7) Noveaulab Asia Corp., and 8) Rainphil Inc. submitted their bid proposals within the prescribed timeline;

**WHEREAS**, during the initial evaluation of bids, the previous BAC declared no bidder submitted a bid for Lot No. 1, while Chemisphere Lab Sciences was disqualified in Lot Nos. 7 and 8 due to non-compliance in the Single Largest Completed Contract (SLCC);

WHEREAS, Chemisphere Lab Sciences declared in their SLCC the amount of Eight Hundred Thirty Thousand Pesos (PhP830,000.00) which is less than 50% of the combined total amount for Lot No. 5 (PhP500,000.00) and Lot No. 7 (PhP1,500,000.00) which they participated in;

WHEREAS, pursuant to Section 23.4.1.3 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, which provides:

the bidder shall have an SLCC that is at least one (1) contract similar to the Project the value of which, adjusted to current prices using the PSA's CPI, must be at least equivalent to: i) completed at least two (2) similar contracts, the aggregate amount of which should be equivalent to at least fifty percent (50%) in the case of non-expendable supplies and services or twenty-five percent (25%) in the case of expendable supplies, and i). The largest of these similar contracts must be equivalent to at least half of the percentage of the ABC as required above;

**WHEREAS**, during the bid evaluation conducted by the previous BAC and Technical Working Group (TWG), the result of ranking, and arithmetical computation were the same with the result of initial evaluation, and all bids that were declared passed during the bid opening are compliant to the technical specifications and other requirements:

WHEREAS, on January 15, 2025 the previous TWG member, Mr. Ralph Aragon, along with the End-User Representative Mr. Jayson Asunto and BAC Secretariat Mr. Jaem Delos Santos conducted the post qualification on Noveaulab Asia Corp. (Lot Nos. 2 and 3) and Golden Bat (Far East) Inc. (Lot Nos. 5, 6 and 7);

WHEREAS, on January 16, 2025 the previous TWG head, Mr. Erwin Acosta, along with the End-User Representative Mr. Jayson Asunto and BAC Secretariat Mr. Jaem Delos Santos conducted the post qualification on Labtraders Inc. (Lot No. 4); WHEREAS, on January 20, 2025 the previous TWG head, Mr. Erwin Acosta, his member Mr. Ralph Aragon, End-User Representative Mr. Jayson Asunto and BAC Secretariat Mr. Jaem Delos Santos conducted the post qualification on Rainphil Inc. (Lot No. 8);

WHEREAS, after a thorough post qualification, the previous TWG recommend that all lowest calculated bids are compliant with the legal, technical and financial requirements as per submitted TWG Post-Qualification Report dated January 23, 2025, and recommending the award of contract to these Lowest/Single Calculated and Responsive Bids (LCRBs);

**WHEREAS**, based on the document presented, the new BAC adapted the recommendation and evaluation of the previous TWG and BAC on the bid proposals submitted by the bidders;

**WHEREAS**, the new BAC, upon review of the documents and processes, collectively agreed to recommend to the HoPE the award of contract to respective Lowest Calculated and Responsive Bid (LCRB) and Single Calculated and Responsive Bid (SCRB) since it all complied to the existing provision of RA No. 9184 and its 2016 revised IRR;
