THIS AGREEMENT made the _____ day of _____ 20____ between **PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY (PhilFIDA)** with principal address at Fiber Processing and Utilization Laboratory, BAI Compound, Visayas Ave., Brgy. Vasra, Quezon City (hereinafter called "the Entity") of the one part and **INDUSTRIAL AND TRANSPORT EQUIPMENT INC. (INTECO)** with principal address at 1127 EDSA Balintawak, Quezon City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly "Supply, Delivery and Testing of Branded and Brand New 6-Wheeler Dropside / Hauling Truck – 3 Units" and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of Seven Million One Hundred Twenty-Eight Thousand Pesos (PhP7,128,000.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. <u>Winning bidder agrees that</u> <u>additional contract documents or information prescribed by the GPPB</u> <u>that are subsequently required for submission after the contract</u> <u>execution, such as the Notice to Proceed, Variation Orders, and Warranty</u> <u>Security, shall likewise form part of the Contract.</u>
- 3. In consideration for the sum of Seven Million One Hundred Twenty-Eight Thousand Pesos (PhP7,128,000.00) or such other sums as may be ascertained, INDUSTRIAL AND TRANSPORT EQUIPMENT INC. (INTECO) agrees to the "Supply, Delivery and Testing of Branded and Brand New 6-Wheeler Dropside / Hauling Truck – 3 Units" in accordance with his/her/its Bid.
- 4. The **Philippine Fiber Industry Development Authority** agrees to pay the above mentioned sum in accordance with the terms of the Bidding.

Bids and Awards Committee Resolution No. 001-2025-EPA

Recommending Award of Contract to Industrial and Transport Equipment, Inc. (INTECO) as a Single Calculated Responsive Bid (SCRB) for the "Early Procurement Activity for the Supply, Delivery, and Testing of Three (3) Units Branded and Brand New 6-Wheeler Dropside/Hauling Truck - Rebidding"

WHEREAS, the Philippine Fiber Industry Development Authority (PhilFIDA) approved Indicative Annual Procurement Plan (IAPP) based on National Expenditure Program (NEP) for FY 2025 includes the procurement of three (3) units branded and brandnew 6wheeler dropside/hauling truck with an Approved Budget for Contract of Seven Million Two Hundred Thousand Pesos (PhP7,200,000.00);

WHEREAS, GPPB Circular No. 06-2019 dated July 17, 2019, allow government agencies to conduct early procurement activities based on an approved Indicative Annual Procurement Plan, but awarding of contract shall only be issued upon approval of the Government Appropriations Act for 2025 and procurement entity's revised FY 2025 APP.

WHEREAS, the Bids and Awards Committee conducted the first opening of bid for this procurement project on December 3, 2024 but declared by the BAC as failure due to no bid proposal receipt within the bid submission timeline;

WHEREAS, the BAC published on PhilGEPS the rebidding through public bidding under Reference No. 11573894 and conducted 2nd opening of bid on December 26, 2024;

WHEREAS, during the 2nd bid opening, only the Industrial and Transport Equipment, Inc. (INTECO) joined the bidding and complied the legal, technical, and financial documentary requirements with a bid price of Seven Million One Hundred Twenty-Eight Thousand Pesos (PhP7,128,000);

WHEREAS, the post qualification and evaluation report submitted by the Technical Working Group (TWG) on Motor Vehicle recommends to the BAC the awarding of contract to the lone bidder as it complies with all the documentary requirements needed during the post-qualification conducted on January 6, 2025;

WHEREAS, upon review of the TWG's report, the BAC unanimously agreed to recommend the award of contract for the procurement of the above-mentioned vehicle to the lone bidder in accordance with the existing guidelines on "early procurement activities";

WHEREFORE, the BAC, RESOLVED, AS IT IS HEREBY RESOLVED to recommend to the Head of the Procuring Entity (HoPE) the award of contract for Supply, Delivery, and Testing of Three (3) Units Branded and Brand New 6-Wheeler Dropside/Hauling Truck to the lone bidder, the Industrial and Transport Equipment, Inc. (INTECO) in the amount of Seven Million One Hundred Twenty-Eight Thousand Pesos (PhP7,128,000.00) in accordance with the guidelines of early procurement activities.
