We discussed during the Pre-Bid meeting that Bids will be fixed and not discounted.	Attached herewith is the above listed bid form. As stated in letter d. of the Bid Form, a bidder can offer a discount, a certain percentage of their total Bid Price.
	Upon discussion with our Central Office BAC, we have come to a conclusion that it would be for the best interest of the Government to accept the discount offered by the bidder.
	Therefore, the BAC of PhilFIDA RSO VI decided to acknowledge the discount offered by the bidder. The total Bid Price of bidders that will offer a discount, will be computed as Total Bid Price less the discount offered. Whereas, bidders that will offer a fixed price, it will be considered as their total Bid Price.

The above-mentioned amendments and clarifications have been duly discussed, deliberated and resolved by the BAC and were made to clarify issues presented during the Pre- bid Conference held last February 10, 2025 at the PhilFIDA RSO VI, Jaro, Iloilo City.
