WHEREAS, the Philippine Fiber Industry Development Authority, Research Center I, prepared the Purchase Request No. 2025-02-061 dated February 27, 2025 for the procurement on the Provision of Materials for the Construction of the Proposed Storage Room 1.90m X 2.50m (4.75 sq.m.) for the Agricultural Cottonseeds in Batac (1 Lot) with an ABC of PhP177,500.00;

WHEREAS, the BAC posted Request for Quotation (RFQ) at the PhilGEPS website with Reference No. 11869278 on March 12, 2025 with a duration of seven (7) calendar days, thus the closing date was on March 19, 2025;

WHEREAS, in response to the said posting, one (1) bidder submitted price quotation however, upon validation of the committee, a discrepancy on the unit cost declared in one of the items was observed and the required documentary requirements were insufficient;

WHEREAS, the BAC re-posted the Request for Quotation (RFQ) at the PhilGEPS website with Reference No. 11916007 on March 25, 2025 with a duration of seven (7) calendar days, thus closing date was on March 31, 2025 at 9:30 AM;

WHEREAS, in response latter posting, one (1) bidder/supplier submitted price quotations therefore, the BAC conducted bid opening and bid evaluation on March 31, 2025 at 10:00 am;

WHEREAS, the bidder passed the documentary requirements for the procurement on the Provision of Materials for the Construction of the Proposed Storage Room 1.90m X 2.50m (4.75 sq.m.) for the Agricultural Cottonseeds in Batac (1 Lot), Black Ace Corporation offered a bid of One Hundred Seventy-Six Thousand Pesos (PhP176,000.00);
