CONTRACT AGREEMENT No.: CA-25-005


This AGREEMENT made this 10th day of June 2025 between PHILIPPINE FIBER INDUSTRY DEVELOPMENT AUTHORITY (Philfida) REGIONAL OFFICE XI with office address at 2nd Floor CAM Building, Monteverde St., Davao City, hereinafter called as the "ENTITY" of the one part and LEISON'S REALTY AND DEVELOPMENT CORP., with office address at Acacia St., Juna Subd., Matina, Davao City hereinafter called as the "SUPPLIER" of the other part.



 - (b) the Entity's Notification of Award;
 - (c) the Omnibus of Sworn Statement with the Special Power of Attorney;

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the goods and services and to remedy defects in conformity in all respects with the provisions of the Contract.

4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects therein, the Contract Price or such other sum as may become payable under the provisions of the Contract at the time and in the manner prescribed by the contract.

5. Aside from the liquidated damages to be paid by the supplier in case of delay as stipulated in the Supplier's Price Quotation, the Procuring Entity may rescind this Agreement in case of the unreasonable failure of the Supplier to deliver the goods and services. Such rescission may be done extra judicially by the Procuring Entity.

6. Any court action which may accrue in relation to this Agreement shall be tried exclusively in the Regional Trial Courts of Davao City Hall.


