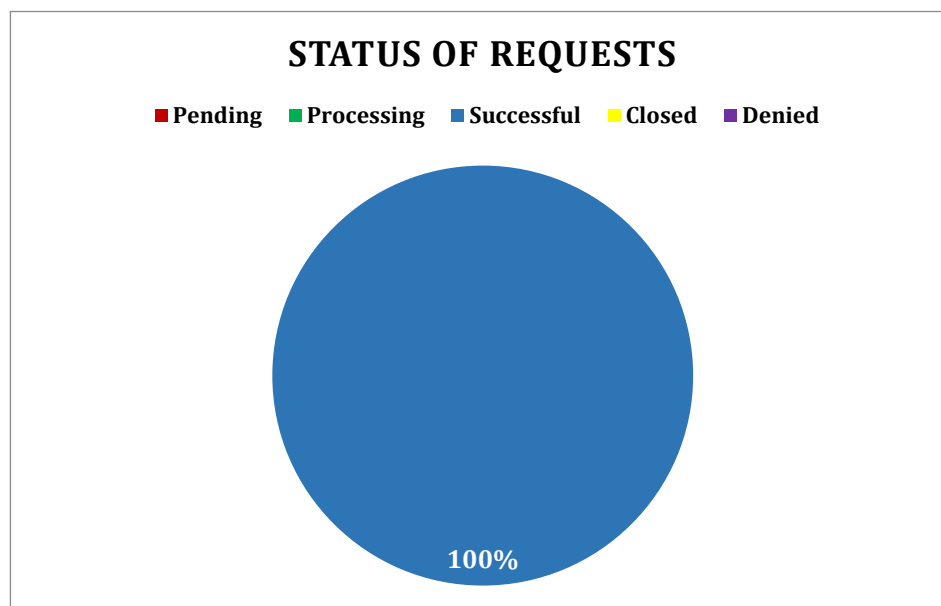


Figure 1: Status of Requests Pie Graph

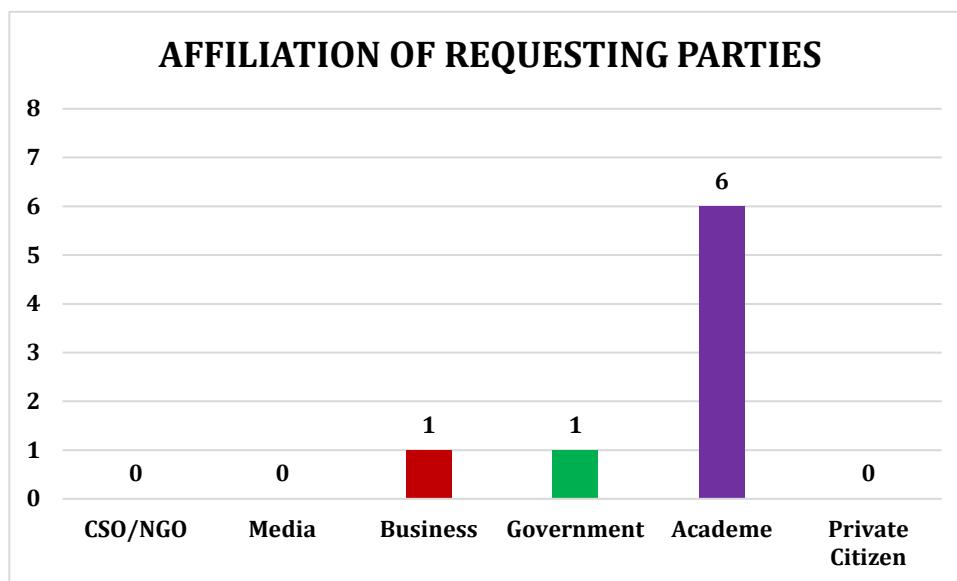


Figure 2: Affiliation of Requesting Parties Bar Graph

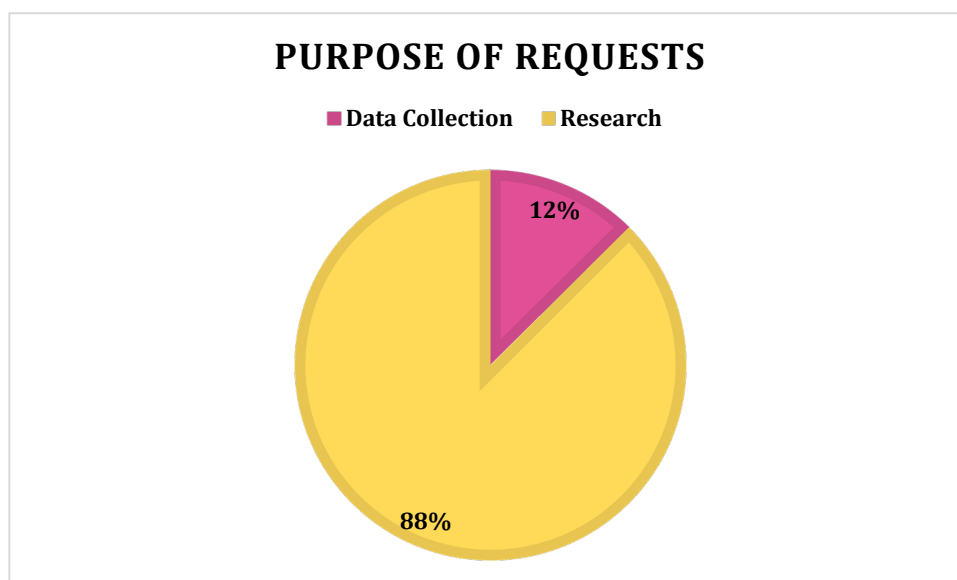



Figure 3: Purpose of Requests Pie Graph
