# POJADA The Real and Present Danger

## What is Pojada?

An unsustainable practice of forcibly and indiscriminately cutting immature abaca stalks in the process of harvesting and stripping by farm contractors for a contracted price agreed with the plantation owner.

This system usually results to overharvesting of abaca as contractors aimed to maximize income/profit.

# Why fiber traders resort to this system?

- 1. There is shortage in fiber supply, thus, traders look for ONE TIME, BIG TIME SUPPLY of abaca.
- 2. Unavailability and/ or diminishing number of skilled manual strippers.
- 3. Farmers who are in dire need of instant cash are easy preys to "pojada" system.

# What are the negative effects of POJADA?

- 1. Farm yield/average fiber production per hectare and farmers' income may decrease by 70%;
- 2. Diseases spread through mechanical means;
- 3. Poor fiber quality resulting from mixing fibers of mature and immature stalks;
- 4. Overharvesting may take 18-24 months for abaca to recover;
- 5. Suppressed growth and development of abaca.

# Measures to suppress this practice:

- 1. Massive information dissemination and campaign at field level.
- 2. Coordination with Local Government Units, Sangguniang Bayan, Sangguniang Panlalawigan re: passage of a local ordinance that will prohibit/penalize violators.
- 3. Launch "SAVE ABACA, NO TO POJADA" in cooperation with Local Government Units, Philippine National Police, Department of Agriculture and other agencies
- 4. Continuous feedback/monitoring and surveillance by all stakeholders.
